BDO, an international network of accounting, tax, and consultancy firms, was established in 1963. The network has continuously expanded its global presence and services over the past 61 years.

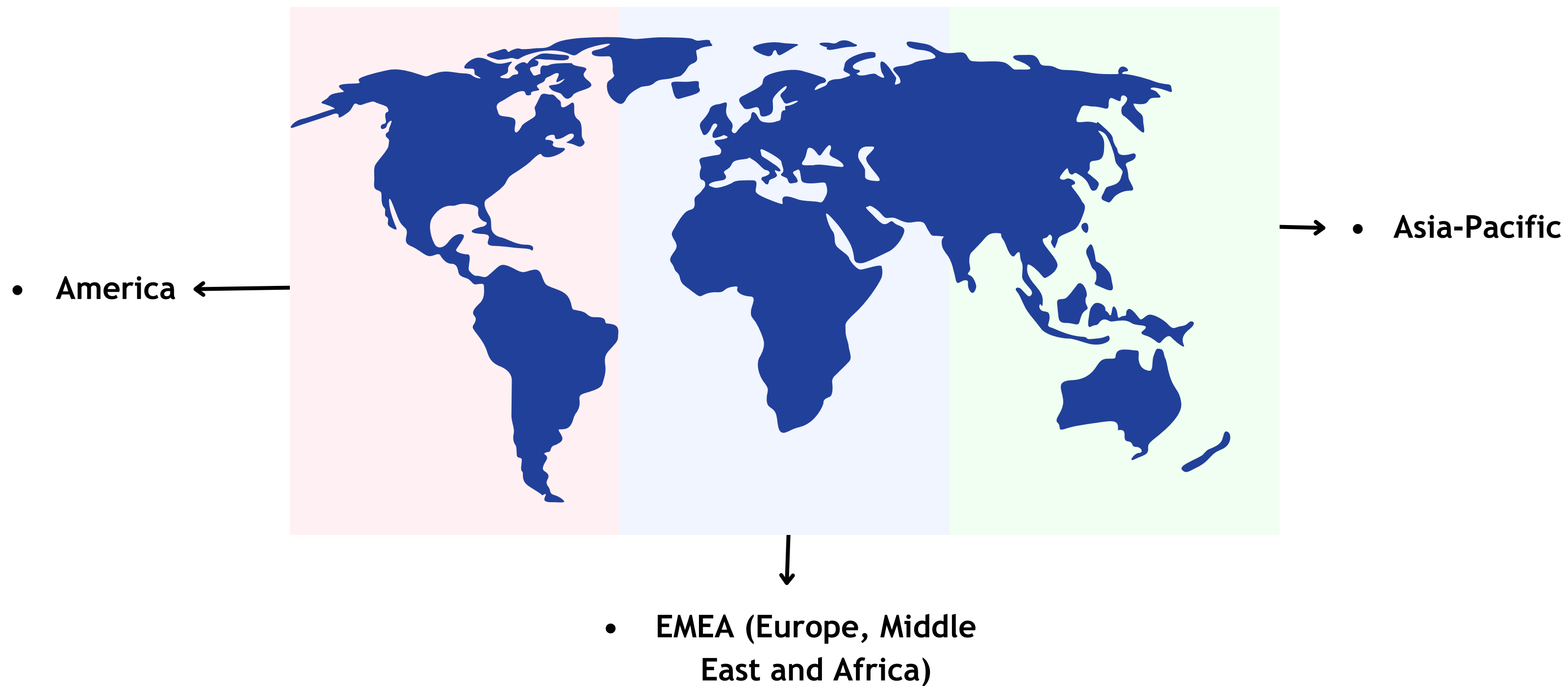
